Province # 2

- Meeting of the Province Level Health and Nutrition Cluster is regular. COVID-19 and regular programs are discussed.
- WFP supported Blanket Supplementary Feeding Program (BSFP) has been halted for sometime in targeted Palikas of Province #2.
 - Till date, total of 7,152 pregnant and lactating women and 12,660 children under 5 years age were benefitted with BSFP in Saptari, Siraha, Sarlahi and Rautahat (Total 19,812)

- **UNICEF** has been supporting for risk communication in province # 2. 180,000 people reached through COVID KURA and 240,000 people reached through 32 FMs of province #2.
- 3 NRHs are functional. Total 15 New SAM children are admitted in 3 NRHs in two weeks' time. Rajbiraj NRH has 4, Janakpur NRH has 8 and Birgunj NRH has 7 SAM children under treatment.
- 400 SAM cases out of 475 SAM cases identified during Vitamin A have been admitted in the OTCs

WHH/Aasaman Nepal/Forward Nepal supported following in Rautahat:

- Supported Food Relief items to 400 HH of Covid-19 Positive, Dalit and Poor in Paroha Municipality of Rautahat.
- MUAC screening in Paroha Municiplity has been completed.
 - Total no of Screening (6-59 months)- 4544
 - Normal: 4019 (88.45%)
 - MAM: 458 (10.07%)
 - SAM: 66 (1.45%)- All admitted in the OTC

Similarly, WHH/Aasaman Nepal/Forward Nepal supported following in Saptari:

- Supported 1000 Flyer on Hand washing pictorial message,
- 1000 flyer on message on Breast feeding and maternal and child Nutrition during covid-19,
- 1000 flyer on message to pregnant and child nutrition during Covid-19 to the health posts of Rajgadh Rural Municipality.
- Provided 60 Pcs (120 ml) hand sanitizer and 300 Pcs masks to Health post of Rajgadh Rural Municipality.
- Distribution of Nutrition Supplementation Package (Litto, Ghee, Daal and eggs) to the SAM/MAM children has been started in Rajgadh Rural Municipality.
